- Firearm replicas are not to be used by parade participants at any time, stationary cannon's are allowed. _____ (Initials)
- Any item to be handed out to parade crowds must be approved in advance by the Organizing Committee. _____ (Initials)
- No items of any kind may be thrown from a vehicle, float or trailer. All distributed items must be delivered to the side of the road by people on foot. _____ (Initials)
- Items that are potentially dangerous, such as silly string, squirt guns may not be used at anytime. _____ (Initials)
- Combining of units is not allowed without the prior consent of the parade organizer. _____ (Initials)
- All Units must maintain a forward motion at all times _____ (Initials)
- Equine Units are required to have a clean-up crew following the unit _____ (initials)

FLYERS Any entry wishing to hand out flyers must pay a \$25.00 clean up fee in addition to all other fees in order to assist with the clean-up costs. _____ (Initials)

DEADLINE All applications should be returned no later than June 15, 2007.
